- 3. MCPS hereby grants to the licensee a licence from the commencement date for the duration of this agreement to make recordings for the purpose of simultaneous broadcast of programming containing recordings of our members' works via a website controlled solely by the licensee.
- 4. MCPS hereby grants to the licensee a licence from the commencement date for the duration of this agreement to make recordings for the purpose of simultaneous broadcast of our members' Production Music Works and the associated Production Music Sound Recordings as dubbed into commercial advertisements produced in-house via a website controlled solely by the licensee.
- 5. The licensee hereby agrees to complete notification forms containing a full and accurate account of our members Production Music Works and the associated Production Music Sound Recordings as dubbed into commercial advertisements produced in-house and only to be broadcast by the Licensee and to return them to the MCPS within 10 working days of the end of each calendar month.
- 6. - 4. to record a musical work other than a production music work into a sponsorship message for broadcast on the station;
- 5. to make, cause or permit to made any parodied or burlesqued versions of any work or any part thereof except with the prior written consent of the copyright owners or their agents;
- 6. to reproduce the lyrics or musical notation of a work in graphic form.
- 7. All rights in the works and Production Music Works and Production Music Sound Recordings other than those specifically herein granted are reserved.
- 8. Nothing in this agreement shall impose liabilities on the MCPS in respect of works in which they do not own or control the mechanical rights for the purpose of this agreement.
- 9. Nothing in this agreement shall affect the moral rights of any author or composer arising under legislation for the time being in force in any country.

PROPER LAW
